The fines levied by BSE relate to the delay in submission of such filings. Upon receipt of the BSE direction dated 9th March 2026, the Company ensured immediate settlement of all dues on 10th March 2026 itself. A residual amount of Rs. 1,000 (plus applicable GST), pertaining to an additional levy of which the Company had no prior intimation, was identified through proactive follow-up with BSE and was promptly paid on the same day.
